#### 14. APPROVE BIOSOLIDS HAULING AND REUSE CONTRACTING

General Manager Thornton explained how biosolids are a by-product of the wastewater treatment process. Biosolids can be used to condition soil and fertilize non-human consumption crops or vegetation. Land application occurs through surface spreading, tilling, or injection below the surface. SEJPA, along with many other Southern California treatment facilities, rely on contractors to transport and land apply biosolids for use at farms in Yuma County, Arizona. Recycling biosolids in Yuma Arizona has been found to be a cost effective option for treatment plants in the San Diego area. SEJPA and Encina

Wastewater Authority staff prepared a bid solicitation for biosolids hauling and reuse. Bids were received on May 23, 2019. Denali Water Solutions submitted the low bid proposal of \$51.50 per ton with an estimated FY 2019-20 cost of \$203,700. The FY 2019-20 Recommended Budget includes \$180,000 for biosolids hauling and reuse, and has an additional \$28,000 in contingency funding.





#### **DISCUSSION**

#### Monthly Treatment Plant Performance and Evaluation


Figure 1 (attached) provides monthly demands for recycled water since deliveries began in September 2000. Figure 2 (attached) provides a graphical view of annual recycled water demand spanning the last 18 fiscal years. Figure 3 (attached) shows the monthly recycled water demand for each May since the program began. Figure 4 (attached) compares budget versus actual recycled water sales for FY 2018-19; showing sales are trending slightly below budget.

Wastewater treatment for the San Elijo Joint Powers Authority (SEJPA) met all National Pollutant Discharge Elimination System (NPDES) ocean effluent limitation requirements for the month of May 2019. The primary indicators of treatment performance include the removal of Carbonaceous Biochemical Oxygen Demand (CBOD) and Total Suspended Solids (TSS). The SEJPA is required to remove a minimum of 85 percent of the CBOD and TSS from the wastewater. Treatment levels for CBOD and TSS were 97.3 and 96.8 percent removal, respectively (as shown in Figure 1 and Figure 2).





#### Member Agency Flows

Presented below are the influent and effluent flows for the month of May. Average daily influent flows were recorded for each Member Agency. Total effluent flow was calculated for the San Elijo Water Reclamation Facility.



For the month of May 2019, recycled water demand was 108.92 acre-feet (AF), which was met using 108.92 AF of recycled water no supplementation with potable water.


May demand was 40% below budget due to cool and wet weather. The total water production for the year is below budget by 11% or 157 AF for the first 11 months of the fiscal year. The decline in recycled water sales is due to higher than expected rainfall and cool weather.





#### RECOMMENDATION

It is recommended that the Board of Directors:

- 1. Authorize the General Manager to enter into an agreement with California Water Technologies, LLC for the procurement of Ferric Chloride for an amount not to exceed \$78,000;
- 2. Discuss and take action as appropriate.

#### BACKGROUND

San Elijo Joint Powers Authority (SEJPA) and Encina Wastewater Authority (EWA) operate similar facilities in north coastal San Diego County. Over the last several years, the agencies have partnered to identify opportunities to share resources, collaborate on mutual aid, and create efficiencies to reduce costs and improve service.

Success has been obtained in shared HR services, work safety collaboration, and emergency response assistance. EWA and SEJPA have also implemented a labor leasing agreement that allows employee sharing between the agencies to address spikes in workloads and fluctuation in staffing, conduct special projects, or other assignments.

In 2016 and 2018, EWA and SEJPA were successful in partnering on opportunities to reduce cost through bulk purchasing of supplies and services. Staff identified two chemicals (Sodium Hypochlorite and Ferric Chloride) that are common to the operation of both agencies and that are purchased in large quantities, usually through multi-year contracts.

Staff worked with Procopio Cory Hargreaves & Savitch LLP to develop joint agency agreements for bulk purchasing of supplies and services. The agreements address purchasing terms and responsibilities of each agency, as well as liability, indemnification, and insurance requirements

to reduce risk to all parties. EWA and SEJPA have found that jointly requesting bids and issuing separate supply contracts is an efficient method of procurement and contract administration.

#### DISCUSSION

EWA staff solicited bids for Ferric Chloride on May 7, 2019 and opened the bids on June 10, 2019. Four vendors responded with only three providing pricing. The results are shown in the Table 1 below:

The low bidder is California Water Technologies. SEJPA has previously purchased ferric chloride from this vendor. Previous service by California Water Technologies was satisfactory with no noted issues or concerns.

#### FISCAL IMPACT

Funding for the proposed Ferric Chloride chemical purchase is budgeted at \$78,028 in SEJPA's Adopted Budget.

It is therefore recommended that the Board of Directors:

- Authorize the General Manager to enter into an agreement with California Water Technologies, LLC for the procurement of Ferric Chloride for an amount not to exceed \$78,000;
- 2. Discuss and take action as appropriate.

#### ATTACHMENT 1

#### **AGREEMENT**

THIS AGREEMENT is made and entered into on this 1<sup>st</sup> day of July, 2019, by and between the San Elijo Joint Powers Authority, a joint powers authority organized and operating pursuant to Government Code Sections 6500 et seq., hereinafter referred to as AUTHORITY, and California Water Technologies, LLC, a Michigan limited liability company, hereinafter referred to as SUPPLIER.

#### WITNESSETH:

WHEREAS, Encina Wastewater Authority (EWA) invited bids for the provision of Ferric Chloride.

WHEREAS, pursuant to said invitation, SUPPLIER submitted a bid which was accepted by EWA for said services.

WHEREAS, AUTHORITY desires and SUPPLIER is willing to provide said services to AUTHORITY on the same pricing terms as EWA.

WHEREAS, the SEJPA Purchasing Policy and Procedures, Section 10.2 authorizes the General Manager to acquire supplies and equipment from or in cooperation with another governmental agency.

NOW THEREFORE, in consideration of their mutual promises, obligations and covenants hereinafter contained, the parties hereto agree as follows:

- 1. <u>TERM</u>. The term of this Agreement shall be from the date this Agreement is made and entered, as first written above, until June 30, 2020, with the option of two (2) additional one (1) year terms at the request of AUTHORITY.
- 2. <u>AUTHORITY'S OBLIGATIONS</u>. For furnishing services or supplies as specified in the Agreement, AUTHORITY will pay and SUPPLIER shall receive compensation for Ferric Chloride at the unit price of \$630 per dry ton. The total amount of Ferric Chloride to be purchased under this Agreement has been estimated to be 123.8 dry tons per year, but actual usage may be considerably less. In no case will total compensation exceed \$78,000. The unit cost and total cost shall include all delivery, tax and shipping charges.

Payments to the SUPPLIER shall be made within forty-five (45) days after receipt of an original invoice from the SUPPLIER and provision of said services to AUTHORITY. SUPPLIER shall invoice no more frequently than monthly for services or supplies provided. Neither AUTHORITY'S acceptance of, nor payment for any of the services, shall be construed to operate as a waiver of any rights under this Agreement or any cause of action arising out of the performance of this Agreement.

3. <u>SUPPLIER'S OBLIGATIONS</u>. For and in consideration of the payments and agreements hereinbefore mentioned to be made and performed by AUTHORITY, SUPPLIER agrees with AUTHORITY to furnish the said services and to do everything required by this Agreement and the said specifications. Without limiting the generality of the foregoing, SUPPLIER warrants on behalf of itself and all sub-SUPPLIERs engaged for the performance of this Agreement that only persons authorized to work in the United States

pursuant to the Immigration Reform and Control Act of 1986 and other applicable laws shall be employed in the performance of the work hereunder. In performing services under this Agreement, SUPPLIER agrees to comply with all laws, rules and regulations and ordinances, whether federal, state or local, and any and all AUTHORITY policies, procedures, departmental rules or other directives applicable to the services to be performed by provided by AUTHORITY'S General Manager or his designee, to SUPPLIER. Any changes to AUTHORITY'S policies and procedures that relate to SUPPLIER will be provided to SUPPLIER in writing. SUPPLIER agrees to review such policies, procedures, rules and directives and the contents of which SUPPLIER will be deemed to have knowledge. SUPPLIER shall ensure that any report generated under this Agreement complies with California Government Code section 7550.

- 4. HOLD HARMLESS AND INDEMNIFICATION. SUPPLIER agrees to defend, indemnify, and hold harmless AUTHORITY, its member agencies (to include the City of Encinitas and the City of Solana Beach), and each of their respective directors, officials, officers, employees, representatives, and agents (collectively, "Indemnified Parties"), from and against all claims, lawsuits, liabilities or damages, including attorney's fees and costs, of whatsoever nature arising out of or in connection with, or relating in any manner to any act or omission of SUPPLIER, its agents, employees, and sub-SUPPLIERs of any tier and employees thereof in connection with the performance or non-performance of this Agreement. The SUPPLIER shall thoroughly investigate any and all claims and indemnify the Indemnified Parties and do whatever is necessary to protect the Indemnified Parties as to any such claims lawsuits, liabilities, expenses, or damages.
- INSURANCE. During the course of the Agreement, SUPPLIER shall pay for and 5. maintain, in full force and effect, all insurance required by any governmental agency having jurisdiction to require particular insurance of SUPPLIER in connection with or related to the work covered hereby. SUPPLIER SHALL FURTHER TAKE OUT AND SHALL FURNISH SATISFACTORY PROOF BY CERTIFICATE OR OTHERWISE AS MAY BE REQUIRED, THAT HE HAS TAKEN OUT COMPREHENSIVE GENERAL LIABILITY INSURANCE AND AUTO LIABILITY WITH AUTHORITY. ITS MEMBER AGENCIES (TO INCLUDE THE CITY OF ENCINITAS AND THE CITY OF SOLANA BEACH), AND EACH OF THEIR RESPECTIVE DIRECTORS, OFFICIALS, OFFICERS, EMPLOYEES, REPRESENTATIVES AND AGENTS ("INSURED PARTIES") NAMED HEREIN AS ADDITIONAL INSUREDS, AS WELL AS ALL OTHER COVERAGE REQUIRED BY THIS AGREEMENT. Insurance carrier shall be satisfactory to AUTHORITY, and insurance shall be purchased from insurance companies with a current A.M. Best rating of no less than A:VII, unless otherwise agreed in writing by AUTHORITY. Insurance shall be in such form approved by AUTHORITY so as to protect all Insured Parties against loss from liability assumed by contract or imposed by law from damages on account of bodily injury, including death resulting therefrom, suffered or alleged to have been suffered by any person or persons, other than employees, resulting directly or indirectly from the negligent performance or execution of this Agreement by SUPPLIER or any subcontract with SUPPLIER thereunder, and also to protect all Insured Parties against loss from liability imposed by law for damage to any property, caused directly or indirectly by the negligent performance or execution or the Agreement by SUPPLIER; which insurance shall also cover accidents arising out of the use and operation of owned, non-owned and hired automobiles, trucks, and/or other mobile equipment. Automobile liability shall be at least as broad as form number CA 0001, covering code 1 (any auto), covering bodily injury and property damage, with a combined single limit of no less than \$1,000,000 per claim for bodily injury and property

damage. General liability shall be at least as broad as occurrence form CG 0001, covering bodily injury, personal injury and property damage. The amounts of coverage of said insurance shall not be less than the following:

Public Liability \$1,000,000 single limit/\$3,000,000 aggregate Property Damage \$1,000,000 single limit/\$3,000,000 aggregate

SUPPLIER shall further maintain adequate Worker's Compensation Insurance, including occupational disease provisions, under the laws of the State of California and employer's general liability insurance for the benefit of its employees with a combined single limit of no less than \$1,000,000 per claim for bodily injury or disease, and shall require similar insurance to be provided by its sub-SUPPLIERs. A certificate shall be furnished to AUTHORITY showing compliance with above.

Said policies shall have a non-cancellation clause providing that thirty (30) days written notice shall be given to AUTHORITY prior to any material modification or cancellation, and a certificate of such insurance shall be furnished to AUTHORITY by direct mail from SUPPLIER'S insurance carrier and shall specifically cover any contractual liability incurred hereunder.

All insurance policies shall be on an occurrence basis and cover the period of performance under this Agreement.

The coverage shall contain no special limitations on the scope of protection afforded to the Insured Parties.

SUPPLIER'S Insurance shall be primary insurance as respects the Insured Parties, and each of them. Any insurance, self-insurance or other coverage maintained by Insured Parties shall be excess of the SUPPLIER'S insurance and not contribute to it.

SUPPLIER hereby agrees to waive rights of subrogation which any insurer of SUPPLIER may acquire from SUPPLIER by virtue of the payment of any loss. SUPPLIER agrees to obtain any endorsement that may be necessary to affect this waiver of subrogation. The workers' compensation policy shall be endorsed with a waiver of subrogation in favor of the Insured Parties for all work performed by the SUPPLIER, its employees, agents and sub-SUPPLIERs.

Any failure to comply with reporting or other provisions of the policies including breaches of warranties shall not affect coverage provided to Insured Parties.

SUPPLIER'S insurance shall apply separately to each insured against whom a claim is made or suit is brought, except with respect to the limits of insurer's liability.

All insurance policies shall specifically cover any contractual liability incurred pursuant to this Agreement.

Any deductibles or self-insured retention limits must be disclosed to and approved by AUTHORITY prior to execution of this Agreement. At the option of AUTHORITY, either: the insurer shall reduce or eliminate such deductibles as respects the Insured Parties; or SUPPLIER shall provide a financial guarantee satisfactory to AUTHORITY guaranteeing

payment of losses and related investigations, claim administration and defense expenses.

SUPPLIER shall furnish to AUTHORITY certificates of insurance prior to the commencement of work under this Agreement, and as may be periodically requested by AUTHORITY. SUPPLIER shall include all endorsements necessary to comply with this Agreement, including additional insured endorsements, signed by the insurer's representative. Such evidence shall include confirmation that coverage includes or has been modified to include all provisions required by this Agreement. SUPPLIER shall, upon request of AUTHORITY at any time, deliver to AUTHORITY complete, certified copies of the policies of insurance, including endorsements, and receipts for payment or premiums thereon, required by this Agreement. Failure to obtain the required documents prior to the work beginning shall not waive SUPPLIER'S obligation to provide them.

If any of the required coverages expire during the term of this Agreement, SUPPLIER shall deliver the renewal certificate(s) including the general liability and auto liability additional insured endorsements to AUTHORITY at least ten (10) days prior to the expiration date.

In the event that SUPPLIER employs sub-SUPPLIERs to perform any portion of the services to be performed pursuant to this Agreement, it shall be SUPPLIER'S responsibility to require and confirm that each sub-SUPPLIER meets the minimum insurance requirements specified in this Agreement.

- 6. <u>AMENDMENTS</u>. Any amendment, modification, or variation from the terms of this Agreement shall be in writing and shall be effective only upon written approval by the Manager of the AUTHORITY.
- 7. TERMINATION. If, during the term of this contract, AUTHORITY determines that SUPPLIER is not faithfully abiding by any term or condition contained herein, AUTHORITY may notify SUPPLIER in writing of such defect or failure to perform; which notice must give SUPPLIER five (5) working days thereafter in which to perform said work or cure the deficiency. If SUPPLIER has not performed the work or cured the deficiency within five (5) days specified in the notice, such shall constitute a breach of this contract and AUTHORITY may terminate this contract immediately by written notice to SUPPLIER to said effect. Thereafter, neither party shall have any further duties, obligations, responsibilities, or rights under this Agreement, except, however, any and all indemnification, hold harmless and defense obligations of SUPPLIER shall remain in full force and effect, and shall not be extinguished, reduced, or in any manner waived by the termination hereof. In said event, SUPPLIER shall be entitled to the reasonable value of its services performed from the beginning of the period in which the breach occurs up to the day it received AUTHORITY's Notice of Termination, minus any offset from such payment representing AUTHORITY's damages from such breach. AUTHORITY reserves the right to delay any such payment, to allow for a full and complete accounting of costs. In no event, however, shall SUPPLIER be entitled to receive in excess of the compensation quoted in its bid.
- 8. <u>STATUS OF SUPPLIER</u>. SUPPLIER and its employee(s) are engaged in an independent SUPPLIER relationship with AUTHORITY in performing all work, duties and obligations hereunder. AUTHORITY shall not exercise any control or direction over the methods by which SUPPLIER shall perform its work and functions. AUTHORITY'S sole

interest and responsibility is to ensure that the services covered by this Agreement are performed and rendered in a competent, satisfactory and legal manner. SUPPLIER represents that its employee(s) have the qualifications and skills necessary to perform the services under this Agreement in a competent, professional manner, without the advice or direction of AUTHORITY. SUPPLIER will supply all tools, materials and equipment required to perform the services under this Agreement. The parties agree that no work, act, commission or omission of SUPPLIER or its employee(s) pursuant to this Agreement shall be construed to make SUPPLIER and its employee(s) the agent, employee or servant of AUTHORITY. SUPPLIER and its employee(s) are not entitled to receive from AUTHORITY vacation pay, sick leave, retirement benefits, Social Security, workers' compensation, disability benefits, unemployment benefits or any other employee benefit of any kind. SUPPLIER shall be solely responsible for paying all federal and statement employment and income taxes, for carrying workers' compensation insurance and for otherwise complying with all other employment law requirements with respect to SUPPLIER or its employee(s). To the maximum extent allowable by law, SUPPLIER agrees to indemnify, defend and hold AUTHORITY harmless from any and all liability, damages or losses (including attorney's fees, costs, penalties and fines) AUTHORITY suffers as a result of (a) SUPPLIER'S failure to meet its employer obligations, or (b) a third party's designation of SUPPLIER or its employee as an employee of AUTHORITY, regardless of any actual or alleged negligence by AUTHORITY.

- 9. <u>ASSIGNMENT</u>. Neither this Agreement nor any duties or obligations under this Agreement may be assigned or subcontracted by SUPPLIER without the prior written consent of AUTHORITY. AUTHORITY has entered into this Agreement in order to receive the professional services of SUPPLIER. The provisions of this Agreement shall apply to any sub-SUPPLIER of SUPPLIER. AUTHORITY shall have the right to approve any sub-SUPPLIER agreements, in addition to the written consent required by this section.
- 10. <a href="PROPRIETARY RIGHTS">PROPRIETARY RIGHTS</a>. Any written, printed, graphic, or electronically or magnetically recorded information furnished by AUTHORITY for SUPPLIER'S use are the sole property of AUTHORITY. SUPPLIER and its employee(s) will keep any information identified by AUTHORITY as confidential in the strictest confidence, and will not disclose it by any means to any person except with AUTHORITY approval, and only the extent necessary to perform the services under this Agreement. This prohibition also applies to SUPPLIER'S employees, agents, and sub-SUPPLIERs. On termination of this Agreement, SUPPLIER will promptly return any confidential information in its possession to AUTHORITY.
- 11. <u>PARTIAL INVALIDITY</u>. If any non-material provision of this Agreement is held by a court of competent jurisdiction to be invalid, void, or unenforceable, the remaining provisions will continue in full force and effect without being impaired or invalidated in any way.
- 12. <u>COUNTERPARTS</u>. This Agreement may be executed in counterparts, each of which shall constitute an original, but all of which together shall constitute one and the same agreement, and the signature of any party to any counterpart shall be deemed a signature to, and may be appended to, any other counterpart.
- 13. <u>PROVISIONS REQUIRED BY LAW</u>. Each and every provision of law and clause required by law to be inserted in this Agreement shall be deemed to be inserted herein,

and the Agreement shall be read and enforced as though they were included herein. If through mistake or otherwise any such provision is not inserted, or is not correctly inserted, then upon the request of either party, the Agreement shall forthwith be physically amended to make such insertion.

- 14. GOVERNING LAW. This Agreement and all questions relating to its validity, interpretation, performance, and enforcement (including, without limitation, provisions concerning limitations of actions), shall be governed by and construed in accordance with the laws of the State of California, notwithstanding any conflict-of-laws doctrines of such state or other jurisdiction to the contrary and without the aid of any canon, custom, or rule of law requiring construction against the draftsman.
- 15. <u>JURISDICTION, FORUM AND VENUE</u>. The proper jurisdiction, forum and venue for any claims, causes of action or other proceedings concerning this Agreement shall be in the state and federal courts located in the State of California, County of San Diego. AUTHORITY and SUPPLIER agree not to bring any action or proceeding arising out of or relating to this Agreement in any other jurisdiction, forum or venue. AUTHORITY and SUPPLIER hereby submit to personal jurisdiction in the State of California for the enforcement of this Agreement and hereby waive any and all personal rights under the law of any state to object to jurisdiction within the State of California for the purposes of any legal action or proceeding to enforce this Agreement, whether on grounds of inconvenient forum or otherwise.
- 16. <u>COMPLETE AGREEMENT</u>. This written Agreement, including all writings specifically incorporated herein by reference, shall constitute the complete agreement between the parties hereto. No oral agreement, understanding, or representation not reduced to writing and specifically incorporated herein shall be of any force or effect, nor shall any such oral agreement, understanding, or representation be binding upon the parties hereto.
- 17. <u>AUDIT</u>. AUTHORITY shall have the option of inspecting and/or auditing all records and other written materials used by SUPPLIER in preparing its statements to AUTHORITY as a condition precedent to any payment to SUPPLIER. This Agreement is subject to examination and audit of the State Auditor, at the request of AUTHORITY or as part of any audit of AUTHORITY, for a period of three (3) years after final payment under the Agreement. SUPPLIER shall cooperate with AUTHORITY, including any authorized representatives of AUTHORITY, regarding any such audit at no charge to AUTHORITY.
- 18. <u>NOTICE</u>. All written notices to the parties hereto shall be sent by United States mail, postage prepaid by registered, certified, or first class mail addressed as follows:

Notices shall be deemed communicated as of the day of receipt or the fifth day after mailing, whichever occurs first.

- 19. PROTECTION OF EXISTING FACILITIES AND NON-INTERFERENCE WITH PLANT OPERATIONS. SUPPLIER shall perform his duties in such a way that there will be no damage done to existing facilities and all facilities shall be left in the condition they were in prior to the beginning of the contract. SUPPLIER will also perform all work in such a way that there is no interference with plant operations.
- 20. <u>AUTHORITY TO EXECUTE AGREEMENT</u>. AUTHORITY and SUPPLIER do covenant that the individual executing this agreement on their behalf is a person duly authorized and empowered to execute this Agreement for such party.

#### RECOMMENDATION

It is recommended that the Board of Directors:

- 1. Authorize the General Manager to enter into a Professional Engineering Services Agreement with Fuscoe Engineering, Inc. for an amount not to exceed \$25,300; and
- 2. Discuss and take action as appropriate.

#### **BACKGROUND**

The Water Campus Improvements project requires civil engineering for both the new building construction and related site improvements, as well as the regional bicycle and pedestrian trail. Fuscoe Engineering is providing the civil engineering services for the site improvements portion, which includes underground infrastructure, onsite storm water capture and treat, and general site grading and drainage.

#### **DISCUSSION**

Due to additional permit requirements and adjustments to the regional bicycle and pedestrian path design, revisions to the site plan design are necessary. If approved, Fuscoe Engineering will provide additional engineering services related to revisions to the site plan and area drainage, storm water management water quality requirements, revisions to the site drainage study, and ongoing project coordination.

These services will supplement the ongoing building architectural design to provide site modifications in response to City of Encinitas planning department requirements and additional bike/pedestrian trail design coordination in development of final approved construction plans.

#### **FINANCIAL IMPACT**

Funding for these additional engineering services can be accessed within the project contingency, which has funds of \$880,000.

It is therefore, recommended that the Board of Directors:

- 1. Authorize the General Manager to enter into a Professional Engineering Services Agreement with Fuscoe Engineering, Inc. for an amount not to exceed \$25,300; and
- 2. Discuss and take action as appropriate.

#### **RECOMMENDATION**

It is recommended that the Board of Directors:

- 1. Authorize the General Manager to Purchase Mitigation Credits for an amount not to exceed \$149,500; and
- 2. Discuss and take action as appropriate.

#### **BACKGROUND**

San Elijo Joint Powers Authority (SEJPA) is developing the Water Campus Improvement project (formerly the Building and Site Improvement project) that will include a new facility building, site improvements, and a community bike/pedestrian path. Building improvements include the construction of a new administration, operation, and laboratory building; upgraded physical and cyber security measures; and new public parking equipped with EV charging stations. Site improvements include solar power (roof and ground mounted), potable water and fire-fighting systems enhancements; new perimeter fencing and lighting upgrades; access road improvements; and storm water capture and reuse infrastructure. Transportation improvements include a regional bicycle/pedestrian path connecting Birmingham Drive to Manchester Avenue through SEJPA property and road crossing enhancements at Manchester Avenue.

#### **DISCUSSION**

The Water Campus Improvement project requires the undergrounding of approximately 1,400 linear feet of an existing concrete open channel that conveys storm water through SEJPA's property to the San Elijo Lagoon. This portion of the storm water channel will be replaced with three large diameter pipes buried beneath the project site to provide adequate space for the proposed bike/pedestrian path and associated public parking (see Figure 1 – Project Site Map).

The storm water channel is within the jurisdiction of several resource agencies including the San Diego Regional Water Quality Control Board (RWQCB). It is estimated that the project will impact 0.26 acre (1,400 linear feet) of the concrete-lined channel, which is considered a permanent water quality loss by RWQCB of ephemeral, non-wetland, concrete surface waters that are tributary to San Elijo Lagoon.



FIGURE 1 - Project Site Map

SEJPA met with RWQCB on June 13, 2019, and it was determined that a 1:1 mitigation ratio for 0.26 acre of mitigation credits from the San Luis Rey Mitigation Bank would be acceptable by the RWQCB. The cost of the mitigation would be \$149,500.

Mitigation banks are regional efforts whereby entities incur the cost of acquisition, prospectus, entitlement, permitting, enabling instrument, and construction of larger aquatic resource restoration projects at regionally important locations for the rights to sell-off the mitigation credits over time to buyers in need of mitigation in the region. In-lieu fee programs are similar to mitigation banks in that credits are sold for restoration activities that have already occurred or are ongoing at a regionally important aquatic resource area. Various types of mitigation credits are offered from banks and in-lieu fee programs, including aquatic resource establishment (creation), re-establishment (restoration), rehabilitation (restoration), enhancement, and preservation.

There are two active mitigation banks in San Diego County, the San Luis Rey Mitigation Bank and the Brook Forest Mitigation and Conservation Bank, both of which are located in the San Luis Rey River Watershed. There are no active in-lieu fee programs available in San Diego County. Both banks essentially involved restoring river/stream and floodplain areas to their historic condition after years of being filled and impacted by agricultural practices. The banks are located at locations where the agencies have agreed there is a benefit to the watershed and region. The cost per acre (each credit equals 1.0 acre) at these mitigation banks is \$575,000/acre.

#### FINANCIAL IMPACT

Funding for the mitigation bank credit of \$149,500 is proposed to be from the SEJPA Capital Program Fund. As this was an unplanned expense, this capital expenditure will likely be replenished in FY 2020-21 with cash contribution from SEJPA's two core programs, Wastewater Treatment and Recycled Water.

It is therefore, recommended that the Board of Directors:

- 1. Authorize the General Manager to Purchase Mitigation Credits for an amount not to exceed \$149,500; and
- 2. Discuss and take action as appropriate.

SUBJECT: CAPITAL IMPROVEMENT PROGRAM UPDATE

#### **RECOMMENDATION**

No action required. This memorandum is submitted for information only.

#### **BACKGROUND**

The San Elijo Joint Powers Authority (SEJPA) has the responsibility to maintain permit compliance with regulatory agencies and legal agreements with customers to provide wastewater and recycled water services. Proactive asset management and capital improvement planning are key components in keeping these commitments.

In 2014, SEJPA retained the services of Carollo Engineers to conduct an evaluation of the wastewater and recycled water capital assets owned by SEJPA at the San Elijo Water Reclamation Facility (SEWRF).

The results of the evaluation and Carollo's recommendations were documented in the 2015 Facility Plan. Recommended projects were prioritized using a "triple-bottom line" approach to evaluate and weight each project against the others using three main factors:

- Financial (30%): Implement cost effective projects and solutions. Maximize economic benefits for customers through cost effective operations.
- ✓ Environmental (35%): Meet or exceed permit requirements and minimize reportable violations. Seek sustainable and efficient operational practices, maximize resource recovery, and minimize impacts to the environment.
- ✓ Social (35%): Maintain a high standard of work safety and maximize community benefits through improved aesthetics and recreational uses.

The recommendations from the 2015 Facility Plan created the foundation for the SEJPA Capital Improvement Program, which includes regulatory compliance analysis, risk assessment for system failure, project prioritization, and budgetary cost estimates.

In 2017, SEJPA successfully secured \$23.9 million in a bond offering to fund a majority of recommended capital projects. The SEJPA has also collected \$14.8 million in cash, \$4.7 million

from Caltrans, and anticipates \$1.0 million in grants. Staff bundled the projects into phases in order to prioritize capital spending, streamline project delivery, minimize community impacts, and reduce cost through economies of scale.

#### DISCUSSION

Phase I of the SEJPA Capital Improvement Program is substantially complete and includes the Land Outfall Replacement, Preliminary Treatment Upgrades, and Odor Control Improvements.

- The Land Outfall Replacement project was completed in 2018. This project replaced the
  original 30-inch diameter asbestos-concrete land outfall that was installed in 1965. The
  new pipeline is approximately 2,600 linear feet in length, constructed of high density
  polyethylene, and installed at a depth greater than the original pipeline to minimize
  conflicts with other buried utilities and future construction projects.
- The Preliminary Treatment and Odor Control Upgrades were combined into a single project and will replace antiquated equipment, repair or replace damaged steel and concrete, improve the treatment process performance, and upgrade the odor control system. Construction began in June 2017 and the project reached substantial completion in May 2019.

Phase II of the Capital Program consists of Water Campus Improvements (formerly Building and Site Improvements), Encinitas Ranch Recycled Water Expansion, Electrical System Improvements, and the 2018 Supervisory Control and Data Acquisition (SCADA) Upgrade projects.

The Water Campus Improvements project is currently in the design and permitting phase and includes:

- New buildings
- Road and parking improvements
- Regional bike/pedestrian path in cooperation with Caltrans and the City of Encinitas
- Fire system modernization
- New perimeter fencing, access control, and security improvements
- SCADA and electrical system upgrades
- Solar power generation
- Storm water conveyance, attenuation, and treatment

The Construction Manager At-Risk (CMAR) alternative delivery method was chosen to expedite the project, and to provide cost controls beyond the traditional design-bid-build delivery method. PCL Construction was awarded the contract at the December 2018 Board meeting. Currently, staff is coordinating with resource agencies to obtain project permits. Contribution agreements with Caltrans are in place for engineering, environmental services, and construction cost sharing. Construction is planned to begin in late 2019, however the start date is subject to resource agencies' approval.

The Encinitas Ranch Recycled Water Expansion project includes the construction of pipelines and a water pressure boosting station to serve the Encinitas Ranch Community Association, two agricultural users, and the City of Encinitas trail system. Burtech Pipeline, Inc. was awarded the

construction contract, which began in October 2018, and the project is now substantially complete. Recycled water service is expected to commence in July 2019.

Electrical System Improvements were completed in 2018. These improvements included the replacement of Meter Service No. 2 automatic transfer switch, electrical breaker repair and maintenance, replacement of the control panels within the headworks building, and the completion of an arc-flash study on all high voltage equipment at the SEWRF. The study was performed in compliance with current National Fire Protection Association codes and standards.

In September 2018, the SCADA Upgrade project was awarded to Tesco Controls, Inc. The main elements of the project include new hardware, software, programming, equipment installation, and system testing and commissioning. SCADA upgrades will be performed at six functional areas within the SEWRF and at five wastewater pump stations located within the Cities of Encinitas and Solana Beach. Cybersecurity enhancements will raise security to meet current industry standards. The project is expected to be complete by September 2019.


Phase III, the Solids Treatment Project, is in the pre-design phase. A Project Definition Report (PDR) is currently in development that will identify the preferred project alternatives. The PDR is expected to be complete by late-2019.

#### FINANCIAL IMPACT

Phase I capital budget was estimated at \$13.7 million. Currently these projects are on track to be completed at \$14.95 million, or approximately 9% above budget. The funding strategy is \$8.0 million in cash and \$6.9 million in bond funds.

Phase II capital budget is estimated to be \$21.8 million. The funding strategy is \$1.6 million in cash, \$14.5 million in bond funds, \$4.7 million from Caltrans, 1.0 million in grants.

Funding for Phase I and II are shown in Figure 1 below:



Funding for the capital projects is based on owned or leased capacity by the agencies served, which includes the Cities of Encinitas, Solana Beach, Escondido, and Del Mar, and Rancho Santa Fe Community Services Districts.

Phase III capital budget is estimated at \$7.8 million. This phase is in early development stages and staff is working with engineers to evaluate current technologies and select desired project elements. Phase III will be funded with the remaining bond proceeds and cash contributions.

Budget and funding adjustments will be made as capital projects are developed, awarded, and constructed. The 2017 Clean Water Bonds and grant funding, combined with current and future cash contributions for capital projects, are the financial basis for SEJPA's Capital Improvement Program.



#### **Project Description**

The work included installation of (approximate lengths) 2,600 feet of 30-inch diameter HDPE pipe via horizontal directional drilling (HDD), 400 feet of 30-inch pipe via open trench construction, 300 feet of dual 10-inch force mains via open trench construction, and 110 feet of 60-inch steel casing under Coast Highway. The HDD began at Cardiff State Beach, continued beneath Coast Highway (through the steel casing), the San Elijo Lagoon, NCTD railroad, the Nature Center, and Manchester Avenue before daylighting at the San Elijo Water Reclamation Facility (SEWRF). Tie-ins to the new pipeline were made at the beach and at the SEWRF. Project work sites have been restored after all work was completed. Project was completed with zero work injuries and environmental claims.

#### **Project Description**

Schedule A includes construction of a booster pump station (located at Encinitas Ranch Golf Course) and recycled water pipeline extension. The 1.5 mile small diameter (6-inch to 8-inch) pipeline will serve the community of Encinitas Ranch, two agricultural users, and the City of Encinitas trail system. The project is a key component of the SEJPA's \$2.5M IRWM grant. The project is anticipated to offset 45 acre-feet per year of potable water use for landscape irrigation or approximately 50% of the total IRWM project potable water offset. Schedule B includes construction of 1,100 feet of 6-inch pipeline intended to serve HOA's along Requeza Street, but will not be installed at this time due to lack of water use commitments along the proposed pipeline alignment.




