13. LABORATORY LEASE AGREEMENT

General Manager, Michael Thornton, stated that earlier this year, SEJPA received two unsolicited proposals for leasing laboratory at the San Elijo Water Campus. Both proposals were for conducting water related research/education to address issues of interest for the water/wastewater industry, as well as for the betterment of public health and the environment. At the June 2022 Board meeting, staff recommended and Board directed developing a lease agreement with Trussell Technologies as their proposed research has greater alignment with SEJPA's interest in potable reuse.

SEJPA's attorney has prepared a lease agreement, which has been reviewed and approved by Trussell Technologies. The lease is for a 400 square feet (sf) of dedicated laboratory area. The agreed upon lease price is \$1,200 per month or approximately \$3 per sf and the term is for 3 years, with provisions for either party to exit the lease early, without penalty or cause.

14. CAPITAL IMPROVEMENT PROGRAM UPDATE

General Manager, Michael Thornton, stated that in 2017, SEJPA commenced a phased capital improvement program to replace and upgrade wastewater and recycled water infrastructure.

Phase I of the Capital Program was completed in 2019 for a total cost of \$14.7 million, and Phase II was completed in late 2021 for a total cost of \$23.3 million.

Phase III of the Capital Program consists of a single project focused on replacing the biosolids dewatering system, chemical storage, and refurbishing the building that contains the treatment equipment, as well as replace the electrical switch gear and breaker system that serves the majority of the Water Campus. The dewatering system and electrical switch gear has been operational for 32 years and is at the end of its useful life. The construction phase of the project is expected to be in the range of \$9.8 million to \$11.8 million.

Funding available for Phase III totals \$12 million, which includes contributions from all agencies receiving wastewater services from SEJPA and the use of the remaining funds from the 2017 Clean Water Bonds.

Phase IV consists of projects that advance the agency's sustainability and climate action goals. These projects including photovoltaic solar and energy efficiency, stormwater capture and reuse, recycled water and potable reuse, and process optimization. The solar project was completed in parallel with the Water Campus Improvements project to capture efficiencies with underground utility work. The remaining projects are in various stages of development, which includes project scale, scope, budgets, and funding strategies. Staff is pursuing grant funding and multi-agency collaboration to help fund and advance many of these projects.

15. <u>RECOMMENDED 2022-23 ORGANIZATION AND LABOR CLASSIFICATION</u> ADJUSTMENTS

General Manager, Michael Thornton, stated that SEJPA employs a non-unionized, technical-skilled workforce of less than 30 employees. Occasionally, the General Manager will provide recommendations to add or delete positions to ensure the agency employs the necessary workforce to successfully complete its mission.

The General Manager has reviewed work trends and forecasts that will likely impact human resource needs and is proposing to add the position of Director of Infrastructure and Sustainability to accommodate future needs. The addition of this position will provide a senior level engineer to lead the agency's infrastructure program and sustainability initiatives.

The addition of the proposed position represents a base salary range of \$140,071 to \$206,391. To accommodate the salary within the approved 2022-23 Budget, the General Manager will freeze hiring of the vacant project manager and financial analyst positions, which total \$167,643 to \$256,432 in base salary. Therefore, the net financial impact is expected to be within budget allowances.

16. GENERAL MANAGER'S REPORT

General Manager, Michael Thornton, stated that San Elijo is scheduled to receive \$1 million dollars in Grant funding for the Encinitas Ranch Recycled Water Expansion and the Wanket Reservoir Tank Rehabilitation and Connection Project. This \$1 million is out of a larger \$17.8 million awarded to the North San Diego Water Reuse Coalition from the US Bureau of Reclamation.

General Manager Thornton also stated that due to a slope failure above the San Elijo Water Campus, SEJPA is working with our residential neighbors to develop a design to construct a private storm drainage pipe from the residential area to the regional storm drain system at SEJPA.

General Manager Thornton also stated that BCycle, a local bike share company, approached SEJPA in regards to housing roughly 6 bike docks. If the project develops further, staff will return this item to the Board for approval considerations.

DISCUSSION

Monthly Treatment Plant Performance and Evaluation

Wastewater treatment for the San Elijo Joint Powers Authority (SEJPA) met all National Pollutant Discharge Elimination System (NPDES) ocean effluent limitation requirements for the month of August 2022. The primary indicators of treatment performance include the removal of Carbonaceous Biochemical Oxygen Demand (CBOD) and Total Suspended Solids (TSS). The SEJPA is required to remove a minimum of 85 percent of the CBOD and TSS from the wastewater. Treatment levels for CBOD and TSS were 99.2 and 99.4 percent removal, respectively, during the month of August.





Figure 1 (below) shows historic treatment performance trends for the removal of CBOD and TSS over the last 13 months compared to the permit minimum removal requirement of 85%.





FIGURE 3: TREATED EFFLUENT FLOWS REMOVAL OF TSS

Figures 2 and 3 (below) show historic influent vs effluent CBOD and TSS concentration fluctuations in the strength of the wastewater being received and discharged by the SEJPA.

FIGURE 2: TREATED EFFLUENT FLOWS REMOVAL OF CBOD

Member Agency Flows

Table 1 (below) presents the influent and effluent flows for the month of August. Average daily influent flows were recorded for each Member Agency. Total effluent flow was calculated for the San Elijo Water Campus. Approximately 93% of the influent flow was diverted for recycled water use in August.

Table 2 (below) presents the historical average and unit influent rates per month for each of the Member Agencies during the past 3 years. It also presents the number of connected Equivalent Dwelling Units (EDUs) for each of the Member Agencies during this same time period.




FIGURE 4: SEJPA AVERAGE DAILY FLOWS OVER THE PAST 3 YEARS

Also shown in Figure 4 is the total wastewater treatment capacity of the water campus, 5.25 mgd, of which each Member Agency has the right to 2.2 mgd, Rancho Santa Fe Community Service District leases 0.25 mgd, and the City of Del Mar leases 0.60 mgd.

DISCUSSION

Recycled Water Production

For the month of August 2022, recycled water demand was 271.8 acre-feet (AF), which was met using 267.3 AF of recycled water and 4.5 AF supplementation with potable water. August demand was 25.4% above budget expectations of 217 AF.

Figure 1 (attached) provides a graphical view of annual recycled water demand spanning the last 10 fiscal years, with the overlay of annual rainfall. Since the recycled water program primarily serves outdoor irrigation, annual demand is reduced during wet periods and increases during times of drought. Figure 2 (attached) shows the monthly recycled water demand for each August for the last ten years to provide a year-over-year comparison. Figure 3 (attached) compares budget versus actual recycled water sales for FY 2021-22.

FIGURE 2: AUGUST RECYCLED WATER DEMAND





FIGURE 3: FY2022/23 CUMULATIVE DEMAND VS BUDGET

SUBJECT: OCEAN OUTFALL PLUME TRACKING STUDY

RECOMMENDATION

No action required. This memorandum is submitted for information only.

BACKGROUND

The San Elijo Joint Powers Authority (SEJPA) discharges treated municipal wastewater from the San Elijo Water Campus to the San Elijo Ocean Outfall (SEOO) in accordance with NPDES Permit No. CA0107999 and Regional Board Order No. R9-2018-0003. This Order incorporates both state and federal water quality requirements and has a scheduled renewal frequency of every 5 years.

Similarly, the Regional Board approved Order No. R9-2018-0002 for the City of Escondido (Escondido) that shares the SEOO, and Order No. R9-2018-0059 for the Encina Wastewater Authority (EWA) that discharges treated secondary effluent through the Encina Ocean Outfall (EOO) in Carlsbad. All three Orders established a new series of monitoring and reporting requirements with various work plans and studies to be submitted during the permit period.

For one of the studies, the Regional Board required SEJPA, Escondido, and EWA to determine the movement and fate of wastewater discharged from the outfalls in a Plume Tracking Study. The SEOO and EOO discharges involve similar ocean depths and distances offshore, as well as similar wastewater characteristics and ocean current patterns. SEJPA, Escondido, and EWA agreed that coordination of SEOO and EOO plume tracking activities could yield information that would be instructive in analyzing plume behavior at both outfalls in a more cost effective manner.

DISCUSSION

In November 2020 the SEJPA Board authorized staff to enter into a professional services agreement with Michael Baker International (MBI) to conduct a joint plume tracking study with EWA and Escondido. Field studies using autonomous underwater vehicles (AUVs) and boatmounted sensors were conducted by Michael Baker in September 2021, December 2021, and March 2022. Key data gathered during these studies included ocean water temperature, conductivity, density, salinity, colored dissolved organic matter (CDOM), and fluorescent

dissolved organic matter (fDOM). The data was evaluated by MBI, and a report of the findings has been prepared for submission to the RWQCB.

Conclusions of the plume tracking report can be summarized as follows:

- Ocean health is not affected by the SEOO discharge as the effluent diffuser system mixes
 the discharge efficiently and the discharge becomes indistinguishable from ambient ocean
 water within a few hundred feet of the outfall.
- Nutrients and contaminants that are flushed from the San Elijo Lagoon in normal tidal cycles represent the most substantial threat to nearshore recreation and aquatic life compared to SEOO discharge.
- The conceptual model of the ocean discharge that has been established by data collection and analysis was confirmed by the plume tracking study.

FINANCIAL IMPACT

The cost of the Plume Tracking Study is expected to be \$595,000 and the project is 93% complete. The cost is being shared by SEJPA, Escondido, and EWA based on ocean outfall ownership and flow discharge to the ocean.

AMENDMENT

RECOMMENDATION

It is recommended that the Board of Directors:

- 1. Authorize the General Manager to execute a Third Amendment to the Agreement for Sale of Reclaimed Water with the City of Del Mar and 22nd District Agricultural Association by the San Elijo Joint Powers Authority;
- 2. Discuss and take action as appropriate.

BACKGROUND

The San Elijo Joint Powers Authority (SEJPA) operates a recycled water utility that sells recycled water to four water purveyors; Santa Fe Irrigation District, San Dieguito Water District, Olivenhain Municipal Water District, and the City of Del Mar/22nd District Agricultural Association (22DAA); and also has an interruptible service agreement directly with the Encinitas Ranch Golf Authority. The purveyors then sell the recycled water to end customers.

SEJPA owns most of the recycled water infrastructure system including treatment, storage, and pipelines. The water districts generally own only the recycled water meter that measures the customer's usage and provide customer billing and other needed administrative services. SEJPA works collaboratively with the water purveyors to provide seamless utility and customer service, as well as to meet regulatory quality control and oversight requirements.

SEJPA has individual wholesale water agreements with each water purveyor that includes pricing structure, water quality, and minimum purchase volume. The purpose of the minimum purchase volume is to provide SEJPA a guaranteed "fixed" minimum revenue stream for operational and capital needs. This provides revenue certainty for the program, improving the bonding capacity and credit rating of SEJPA. This revenue structure has been successful for meeting revenue requirements of the program at the lowest possible cost for the customers.

DISCUSSION

During the last fiscal year (FY 2021-22), 22DAA did not meet its minimum purchase volume of 85 acre-feet (AF) as they encountered operational issues that limited usage to 75 AF. Staff from SEJPA and 22DAA discussed the option of providing 22DAA another year to use the

approximately 10 AF that was not used in FY 2021-22. This would require 22DAA to use 95 AF in FY 2022-23. In reviewing the last nine years of recycled water usage by 22DAA, the average annual use is 109 AF with the median use of 111 AF, which is well above last year's usage. For this fiscal year, 22DAA has used 32 AF in three months and they are on track to use 100 AF by year end.

SEJPA staff recommends providing 22DAA another year to capture their minimum purchase volume. Financially, SEJPA reached its budget goals for recycled water sales and revenues in FY 2021-22, which diminishes the need to exercise the minimum purchase requirement. Furthermore, 22DAA has retained SEJPA to operate its Wetlands Treatment System which will likely minimize further operational issues that limited recycled water use.

Staff has prepared the Third Amendment to the Agreement for Sale of Reclaimed Water to the City of Del Mar and the 22nd District Agricultural Association by the San Elijo Joint Powers Authority for Board consideration.

FINANCIAL IMPACT

The financial impact of not collecting the minimum purchase volume is approximately \$17,035. However, SEJPA achieved and slightly exceeded its recycled water sales and revenue goals for FY 2021-22, thus allowing 22DAA to assign the 10 AF to FY 2022-23 without budget impacts.

It is therefore recommended that the Board of Directors:

- 1. Authorize the General Manager to execute a Third Amendment to the Agreement for Sale of Reclaimed Water to the City of Del Mar and the 22nd District Agricultural Association by the San Elijo Joint Powers Authority;
- 2. Discuss and take action as appropriate.

THIRD AMENDMENT TO THE RECLAIMED WATER SALES AGREEMENT BETWEEN THE SAN ELIJO JOINT POWERS AUTHORITY, THE CITY OF DEL MAR, AND THE 22ND DISTRICT AGRICULTURAL ASSOCIATION

This Third Amendment to the Agreement for Sale of Reclaimed Water, hereinafter referred to as the "**Third Amendment**," is made and entered into as of this _____ day of October, 2022, by and between San Elijo Joint Powers Authority (San Elijo JPA), an agency of the State of California, the City of Del Mar (CITY), a municipal corporation and the 22nd District Agricultural Association (DISTRICT), an agency of the State of California.

RECITALS

WHEREAS, the San Elijo JPA and the Reclaimed Water Purveyor have entered into an agreement dated November 5, 1997, with a first amendment dated December 22, 2014 ("First Amendment"), and a second amendment dated July 1, 2020 ("Second Amendment"), for the sale of reclaimed water by the San Elijo JPA to the Reclaimed Water Purveyor, hereinafter referred to as the "Purveyor Agreement"; and

WHEREAS, the parties are interested in adjusting the minimum annual reclaimed water commitments the Reclaimed Water Purveyor is required to purchase, pursuant to the Purveyor Agreement, as most recently amended by the Second Amendment.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, and in consideration of the recitals and the mutual covenants contained herein, and notwithstanding anything to the contrary in the Purveyor Agreement, the San Elijo JPA and Reclaimed Water Purveyor hereby agree as follows:

- 1. The provisions of this Third Amendment shall apply to the sale of reclaimed water by the San Elijo JPA to the Reclaimed Water Purveyor commencing July 1, 2021, through June 30, 2023, as provided herein unless terminated as provided in the Purveyor Agreement or otherwise amended by the parties.
- 2. For the term of this Third Amendment, the San Elijo JPA agrees to supply, and Reclaimed Water Purveyor agrees to purchase from the San Elijo JPA no less than a cumulative one hundred seventy (170) acre-feet ("AF") of reclaimed water during the combined Fiscal Year 2021-22 through Fiscal Year 2022-23 at the applicable water rate set forth by the Second Amendment. In the event Reclaimed Water Purveyor fails to accept the minimum 170 AF in this two-year time frame, Reclaimed Water Purveyor agrees to pay for the difference between the AF accepted by the Reclaimed Water Purveyor during the two-year period and the minimum 170 AF at the applicable reclaimed water rate stated in the Second Amendment.

3. Beginning July 1, 2023, the minimum annual reclaimed water commitment shall revert to an annual requirement of eighty-five (85) AF. In other words, the Reclaimed Water Purveyor agrees to purchase from the San Elijo JPA no less than 85 AF of reclaimed water annually from July 1 through June 30 from year to year on the same terms and conditions as provided in the Purveyor Agreement, as amended, or as otherwise amended by the parties. In the event Reclaimed Water Purveyor fails to accept the minimum 85 AF per year, Reclaimed Water Purveyor agrees to pay for the difference between the AF accepted by the Reclaimed Water Purveyor during the fiscal year and the minimum 85 AF at the applicable reclaimed water rate set forth by the Purveyor Agreement, as amended.

Except as expressly stated and amended herein, the remaining terms and conditions of the Purveyor Agreement, as amended, shall remain in full force and effect. If any provision of the Purveyor Agreement, the First Amendment, or the Second Amendment directly conflicts with a provision in this Third Amendment, the terms of this Third Amendment shall control. The expiration of the provisions of this Third Amendment shall not affect the term of the Purveyor Agreement. Upon expiration of the provisions of this Third Amendment, and unless the parties execute a written agreement otherwise, the terms of the Purveyor Agreement, including any other duly executed amendment thereto which has not expired, shall apply.

IN WITNESS WHEREOF, the parties hereto have caused this Third Amendment to be executed and be effective on the date first mentioned above.
