12. <u>SAN ELIJO JOINT POWERS AUTHORITY MID-YEAR REVIEW OF THE FISCAL</u> YEAR 2011-12 OPERATING BUDGET

The Director of Finance/Administration presented the mid-year analysis of the SEJPA's FY 2011-12 Budget. Greg Lewis stated that it is expected that overall, the SEJPA will be in a strong position to conclude the fiscal year at or slightly below budget. Personnel costs are projected to end the year at budgeted levels while non-personnel costs such as supplies and services should end the year below budgeted levels. Each program has designated contingency funding to address emergency issues, unforeseen repairs, or other unplanned events. At this time, it is not expected that the use of contingency funds will be required. Any funds not expended are returned to the funding agency.

No action required. This memorandum was submitted for information only.

13. RECYCLED WATER PROGRAM UPDATE

The General Manager reported that during the end of 2011 and the start of 2012, the SEJPA has been actively engaging local water districts towards improving program efficiencies, managing costs, and expanding service.

The meetings conducted with the Santa Fe Irrigation District, (SFID), have covered such topics as using the newly completed SFID pipeline to reach new customers and the development of a purchase agreement for transferring ownership of this pipeline to the SEJPA.

The San Dieguito Water District, (SDWD), and the SEJPA conducted several meetings that focused on regional partnership, expanding recycled water use, and cost management. An agreement was reached that provided reconciliation clarity between the Encinitas Ranch Golf Course surplus water agreement and the original recycled water purchase agreement between SDWD and the SEJPA.

The discussions held with Del Mar, the 22nd Agricultural District, have covered expanded use in the fairground's irrigation system and the feasibility for using recycled water in the cooling towers.

The discussions between the SEJPA and the Olivenhain Municipal Water District, (OMWD), have focused on the possibility of developing a recycled water purchase agreement, as currently the SEJPA does not sell recycled water to OMWD.

No action required. This memorandum was submitted for information only.

14. GENERAL MANAGER'S REPORT

The General Manager reported that recycled water is gaining attention and on March 20, 2012, the State Assembly Water, Parks and Wildlife Committee is scheduled to conduct a hearing entitled "Untapped Potential: Water Reuse for California's Future Water Supply Reliability." This hearing is being held to build awareness of water recycling and create a foundation for the Committee's consideration of legislation to revise California's water recycling statues.

15. GENERAL COUNSEL'S REPORT

General Counsel Greg Moser stated that a report came out mid-December on the Local Agency Formation Commission (LAFCO) effectiveness stating that LAFCOs are concerned that they lack any authority over joint powers authorities. The General Counsel stated that there is no legislation in the works at this time, and he will keep the Board posted on any updates.

<u>DISCUSSION</u>

Monthly Treatment Plant Performance and Evaluation

Wastewater treatment for the San Elijo Joint Powers Authority (SEJPA) met all NPDES ocean effluent limitation requirements for the month of January 2012. The primary indicators of treatment performance include the removal of Carbonaceous Biochemical Oxygen Demand (CBOD) and Total Suspended Solids (TSS). The SEJPA is required to remove a minimum of 85 percent of the CBOD and TSS from the wastewater. Treatment levels for CBOD and TSS were 97.7 percent and 96.2 percent, respectively, for January (as shown in Figure 1 and Figure 2).

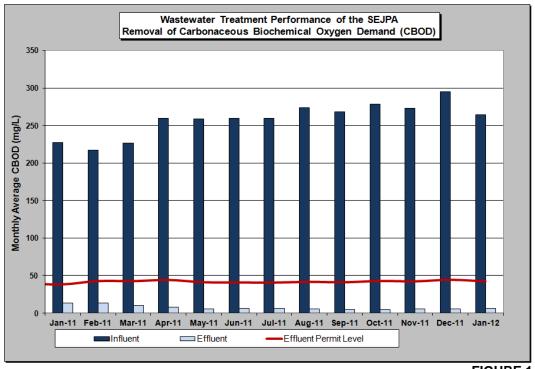

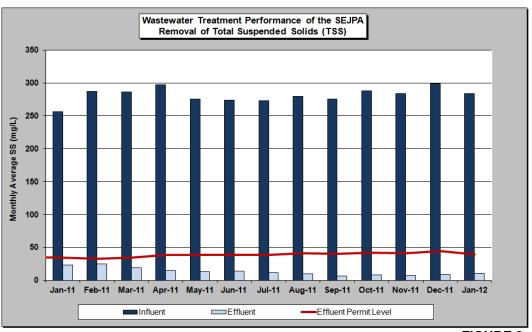

Member Agency Flows

Presented below are the influent and effluent flows for the month of January. Average daily influent flows were recorded for each Member Agency. Total effluent flow was recorded for the San Elijo Water Reclamation Facility.

Notes: As of July 1995, Rancho Santa Fe Community Services District (CSD) combined SID #2 and SID #3 into one Sewer Improvement District (SID).

Table 1 (below) presents the historical average, maximum, and unit influent and effluent flow rates per month for each of the Member Agencies since July 2008. It also presents the number of connected Equivalent Dwelling Units (EDUs) for each of the Member Agencies during this same time period.

Figure 3 (below) presents the historical average daily flows per month for each Member Agency. This is to provide a historical overview of the average treated flow by each agency. As shown in the figure, the average treated flow typically ranges between 2.9 and 3.1 million gallons per day (mgd). Also shown in Figure 3 is the total wastewater treatment capacity of the plant, 5.25 mgd, of which each Member Agency has the right to 2.5 mgd, and Rancho Santa Fe Community Service District has the right to 0.25 mgd.

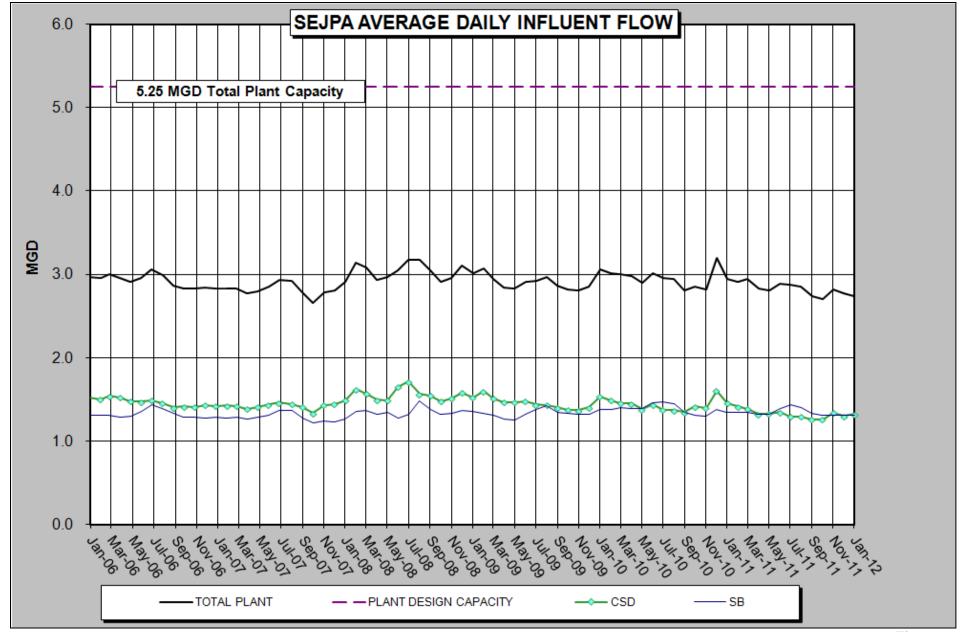

DISCUSSION

Recycled Water Production

For the month of January 2012, recycled water demand was 43.12 acre-feet (AF), which was met using 43.12 AF of recycled water and 0.00 AF of supplementation with potable water. This equates to a blend mix for January of 100.0 percent recycled water and 0.0 percent potable water supplementation.

Figure 1 (attached) provides monthly supply demands for recycled water over the last five years. Figure 2 (attached) provides a graphical view of annual recycled water demand spanning the last eleven fiscal years. Recycled water demand can fluctuate from year to year, which is typically a function of weather. For example, Fiscal Year 2003-04, an unusually dry year, resulted in increased recycled water demand; and Fiscal Year 2004-05, an unusually wet year, resulted in lower recycled water demand.

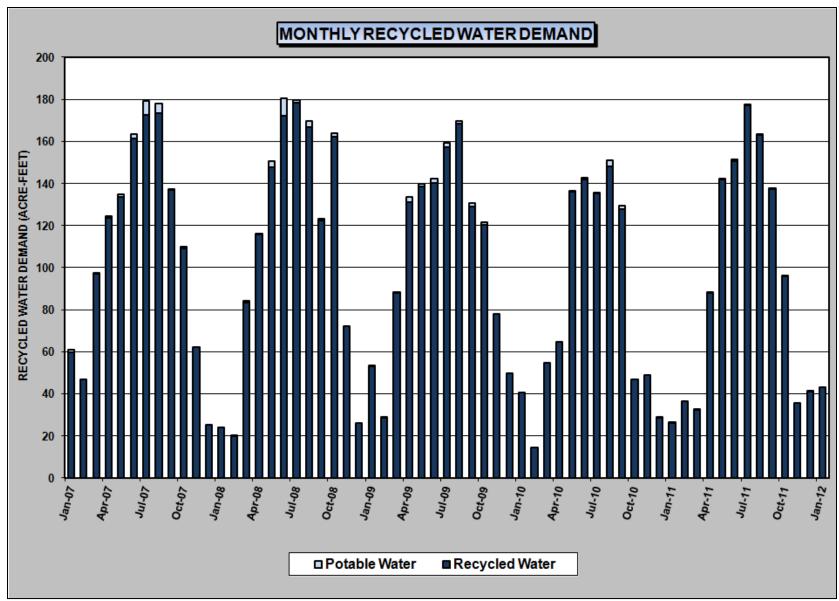

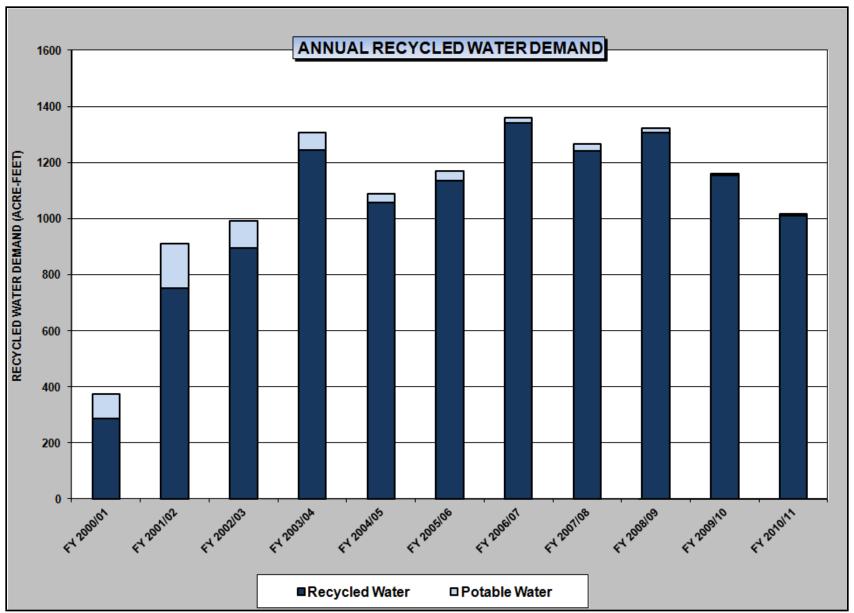

RECOMMENDATION

No action required. This memorandum is submitted for information only.

DISCUSSION

The audit of the San Elijo Joint Powers Authority (SEJPA) for Fiscal Year 2010-11 was completed and presented to the SEJPA Board of Directors in November 2011. The SEJPA auditor, Leaf & Cole, LLP, stated that the SEJPA's financial statements are in conformity with accounting principles generally accepted in the United States of America, as well as the accounting systems prescribed by the State Controller's Office and State Regulations governing Special Districts.

The SEJPA Board requested that the audit process be reviewed and brought back to the Board at a future date. Currently, the existing process begins with receipt of an engagement letter from the audit firm explaining the audit process and fee schedule. The auditors then perform field work to test the accuracy and completeness of the financial statements and financial health of the SEJPA as of the end of the fiscal year being reviewed. The auditors also conduct field interviews with SEJPA management to identify practices and possible weaknesses or areas of improvement. The purpose of the audit is to ensure the SEJPA is complying with the standards established by the Governmental Accounting Standards Board (GASB) in accordance with Generally Accepted Accounting Principles (GAAP). The financial statements are then presented to the SEJPA Board with an explanation of the audit findings. The auditor also issues a Statement on Auditing Standards (SAS) 114 letter to the Board, which discusses any adjustments that were made, any significant estimates made, any new pronouncements implemented, and any difficulties encountered during the audit process. A management letter may also be presented if any irregularities are found or if improvements are recommended to the SEJPA practices or policies relating to the financial system or internal controls.

Currently, during the audit process, the auditors issue a written communication to the Board of Directors to allow Board Members to communicate directly with the auditors to address concerns or questions the Board Members may have. In 2012, the audit process will include a new step where the auditors will verbally communicate and interview each Board Member in an effort to continue improving the audit process and to facilitate good communications between the Board and the auditors.

RECOMMENDATION

It is recommended that the Board of Directors:

- 1. Approve Funding for the Programmatic Environmental Impact Report and Project Feasibility Study, Not-To-Exceed \$60,250;
- 2. Authorize the General Manager to Execute Regional Agreement for Joint Cost Sharing of the Programmatic Environmental Impact Report and Project Feasibility Study, Not-To-Exceed \$60,250; and
- 3. Discuss and take action as appropriate.

BACKGROUND

In 2010, the SEJPA began working collaboratively with several local districts to examine opportunities for expanding recycled water use within North San Diego County. The effort expanded into a working group of twelve governmental organizations, including cities, water districts, sanitation districts, and the Marine Corps Base Camp Pendleton. This collaborative effort is called the North San Diego County Regional Recycled Water Project (Regional Project). Agency members of this project include the San Elijo Joint Powers Authority (SEJPA), Olivenhain Municipal Water District (OMWD), Leucadia Wastewater District, Carlsbad Municipal Water District, Vallecitos Water District, Santa Fe Irrigation District, Vista Irrigation District, City of Oceanside, City of Vista, Rincon Del Diablo Municipal Water District, and the City of Escondido.

The group, through OMWD which serves as the lead agency, retained the firm RMC Engineering to prepare a Regional Recycled Water Facilities Plan. This engineering report presents options for the regionalization of existing and planned reclamation systems of the project members to increase the beneficial use of recycled water. The overarching intent of the

project is to bring a regional perspective to integrating recycled water facilities to maximize benefits at the lowest cost (or greatest value). The report examines opportunities for interconnecting existing recycled water systems, as well as constructing new joint-use facilities such as storage reservoirs and transmission pipelines to efficiently convey, store, and deliver recycled water. Regionalization of facilities can provide cost efficiencies through shared infrastructure and increased facility utilization. Project goals include providing safe, reliable, recycled water as a cost effective local water supply to help meet the future needs in the north San Diego County.

DISCUSSION

The Regional Recycled Water Facilities Plan is expected to be completed by May 2012. The next step in the planning process is to prepare a project feasibility study and a programmatic environmental impact report. The feasibility study will expand upon the work completed in the facility plan and will include a problems and needs assessment, project alternatives analysis, economic analysis, and identification of legal and institutional requirements. The feasibility study will be prepared in accordance with the requirements of the Bureau of Reclamation, Title 16.

A programmatic environmental impact report (PEIR) will be prepared for the preferred alternative identified in the feasibility study. Pursuant to CEQA Guidelines, a PEIR may be prepared for a series of related actions that are characterized as one large project or program. The PEIR will establish the baseline conditions for the overall regional program, as well as disclosure of the totality of potential environmental impacts and mitigations necessary to implement the program. Because CEQA does not allow segmentation of a larger program in order to reduce the overall significance of the environmental impacts, a PEIR appears to be the appropriate documentation for this regional effort.

With the completion of the feasibility study and the PEIR, greater clarity will be gained for a regionalized recycled water program for North San Diego County. The program will likely include a combination of both near-term and long-term projects. Projects being considered include expanding existing irrigation recycled water projects, industrial use of recycled water, development of regional storage, and purification for replenishing drinking water supplies.

The SEJPA currently recycles approximately one-third of the wastewater it receives on an annual basis. To increase its recycling efforts, new markets and service areas need to be reached. It is likely that the proposed feasibility study and PEIR can provide value to the SEJPA for identifying new recycled water opportunities, developing new strategic relationships with partnering agencies, and reaching new markets. In addition, these documents are a prerequisite for securing federal grant funding through the Bureau of Reclamation, which the project group is pursuing. Finally, grant funding has been awarded to the Regional Project that can fund this effort, therefore resulting in zero cost to the SEJPA.

FINANCIAL IMPACT

The anticipated cost for the Programmatic Environmental Impact Report (PEIR) and Project Feasibility Study is approximately \$482,000. It is expected that the SEJPA's portion of this cost will not exceed \$60,250 and these funds are available in the Water Reclamation Program Budget. Furthermore, in 2010 the Regional Project was successful in being awarded \$1.5 million in grant funding, of which \$500,000 was targeted for the completion of a PEIR and Project Feasibility Study. The \$1.5 million grant is expected to be available beginning in May 2012 and upon the completion of PEIR and the Feasibility Study, project costs can be

submitted for full grant reimbursement. Therefore, it is very likely that the preparation of the PEIR and feasibility study will have no cost impact to the SEJPA Recycled Water Program.

It is therefore recommended that the Board of Directors:

- 1. Approve Funding for the Programmatic Environmental Impact Report and Project Feasibility Study, Not-To-Exceed \$60,250;
- 2. Authorize the General Manager to Execute Regional Agreement for Joint Cost Sharing of the Programmatic Environmental Impact Report and Project Feasibility Study, Not-To-Exceed \$60,250; and
- 3. Discuss and take action as appropriate.
