## 14. AUTHORIZE THE GENERAL MANAGER TO EXECUTE A COST SHARING AGREEMENT WITH SAN DIEGUITO WATER DISTRICT, SANTA FE IRRIGATION DISTRICT, LEUCADIA WASTEWATER DISTRICT, AND OLIVENHAIN MUNICIPAL WATER DISTRICT FOR THE DEVELOPMENT OF A REGIONAL RECYCLED WATER EXPANSION PLAN

General Manager Thornton stated that due to droughts and other events that strain and limit California's existing water supplies, water agencies are examining options that go beyond current conventional water supplies to create long-term reliable and sustainable water systems. Project partners, SEJPA, San Dieguito Water District, Santa Fe Irrigation District, Olivenhain Municipal Water District, and Leucadia Wastewater District are interested in defining a recommended project, and evaluating the opportunities and constraints. Santa Fe Irrigation District will serve as the lead agency and retain the consultant for this work. Mr. Thornton stated that staff expects this Regional Recycled Water Expansion Plan to provide clarity on the best options for the next major expansion to the SEJPA's Recycled Water Program.

The total proposed cost for the Regional Recycled Water Plan is \$287,529, with SEJPA's share at 25% or \$71,882. Funding is available in the Recycled Water FY 2017-18 Budget.

Moved by Board Member Mosca and seconded Board Member Zito to:

- 1. Authorize the General Manager to execute the Cost Sharing Agreement with San Dieguito Water District, Santa Fe Irrigation District, Leucadia Wastewater District, and Olivenhain Municipal Water District to jointly fund the development of a Regional Recycled Water Expansion Plan; and
- 2. Authorize the General Manager to Cost Share in an amount not to exceed \$71,882 for the SEJPA.

Roesling Nakamura Terada Architects presented site drawings, building sketches, and floor plans. The General Manager stated that staff is working with Caltrans and the City of Encinitas to refine the bike/pedestrian path and traffic calming measures on Manchester Avenue. Also, Caltrans and the SEJPA are currently developing a cooperative agreement to define project roles and responsibilities, cost sharing terms, and deliverable dates for the transportation elements of the project. Mr. Thornton stated that staff is developing the photovoltaic (PV) systems design with a net-zero energy goal to meet building energy needs with renewable solar power.

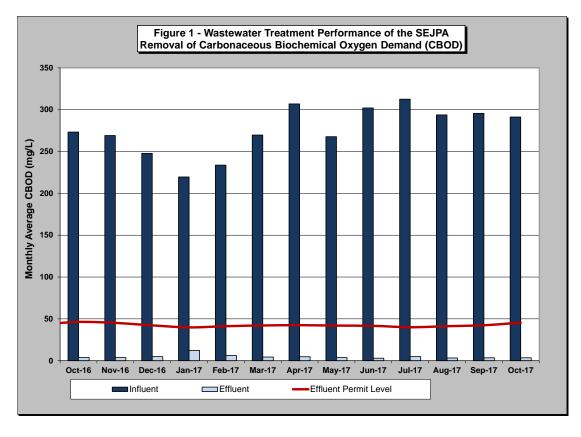

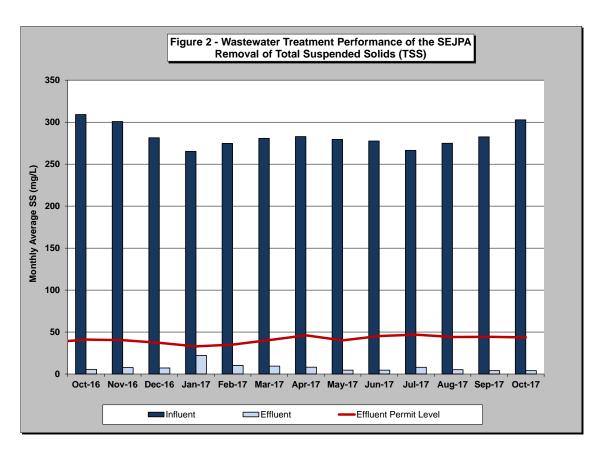

## **DISCUSSION**

## Monthly Treatment Plant Performance and Evaluation

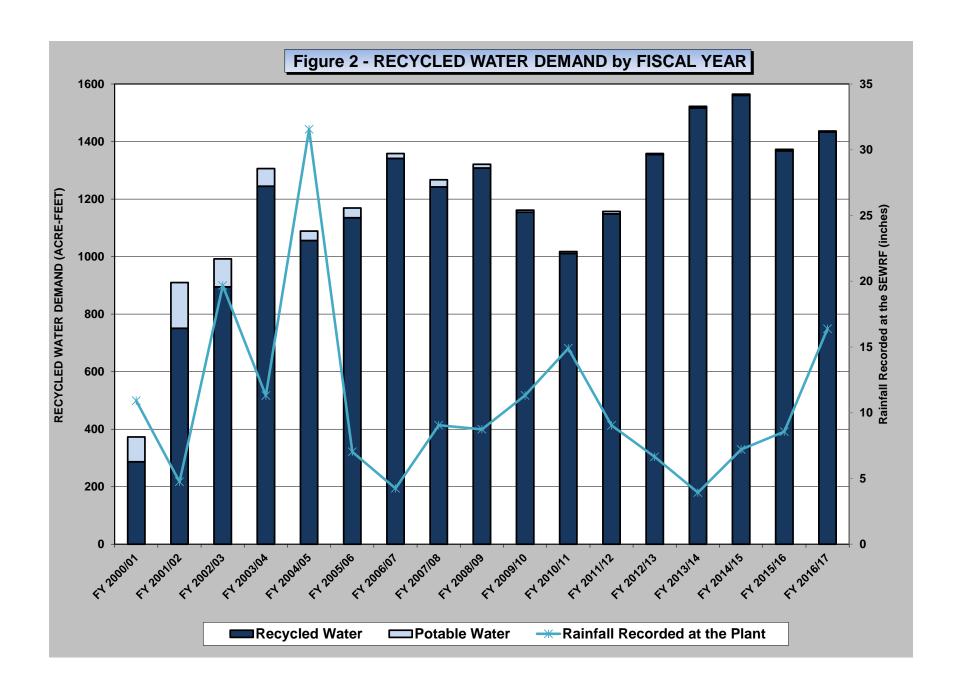
Figure 1 (attached) provides monthly demands for recycled water since deliveries began in September 2000. Figure 2 (attached) provides a graphical view of annual recycled water demand spanning the last seventeen (17) fiscal years. Figure 3 (attached) shows the monthly recycled water demand for each October since the program began. The October demand was second highest since the program began.

Wastewater treatment for the San Elijo Joint Powers Authority (SEJPA) met all National Pollutant Discharge Elimination System (NPDES) ocean effluent limitation requirements for the month of October 2017. The primary indicators of treatment performance include the removal of Carbonaceous Biochemical Oxygen Demand (CBOD) and Total Suspended Solids (TSS). The SEJPA is required to remove a minimum of 85 percent of the CBOD and TSS from the wastewater. Treatment levels for CBOD and TSS were 98.8 and 98.7 percent removal, respectively, (as shown in Figure 1 and Figure 2).





## Member Agency Flows

Presented below are the influent and effluent flows for the month of October. Average daily influent flows were recorded for each Member Agency. Total effluent flow was calculated for the San Elijo Water Reclamation Facility. January 2017 was the first month that the City of Del Mar pumped flow to SEJPA. However, due to the treatment process upset and high influent flows associated with the January rain events, the flow was diverted back to San Diego JPA Metro. Currently, the City of Del Mar is in the process of eliminating high salinity infiltration that is occurring at a few manholes near the beach. High salinity wastewater can negatively impact the biological treatment and water recycling process. Upon the completion of these repairs, the SEJPA will begin receiving wastewater flows from Del Mar.

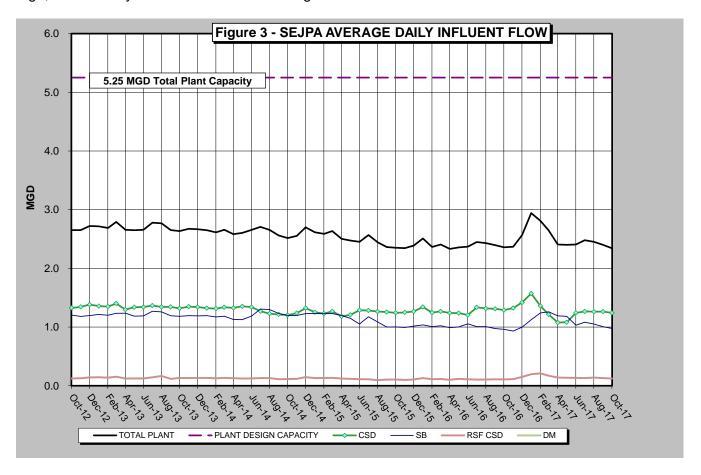

Also shown in Figure 3 is the total wastewater treatment capacity of the plant, 5.25 mgd, of which each Member Agency has the right to 2.2 mgd, Rancho Santa Fe Community Service District leases 0.25 mgd, and the City of Del Mar leases 0.60 mgd.

Recycled Water Production

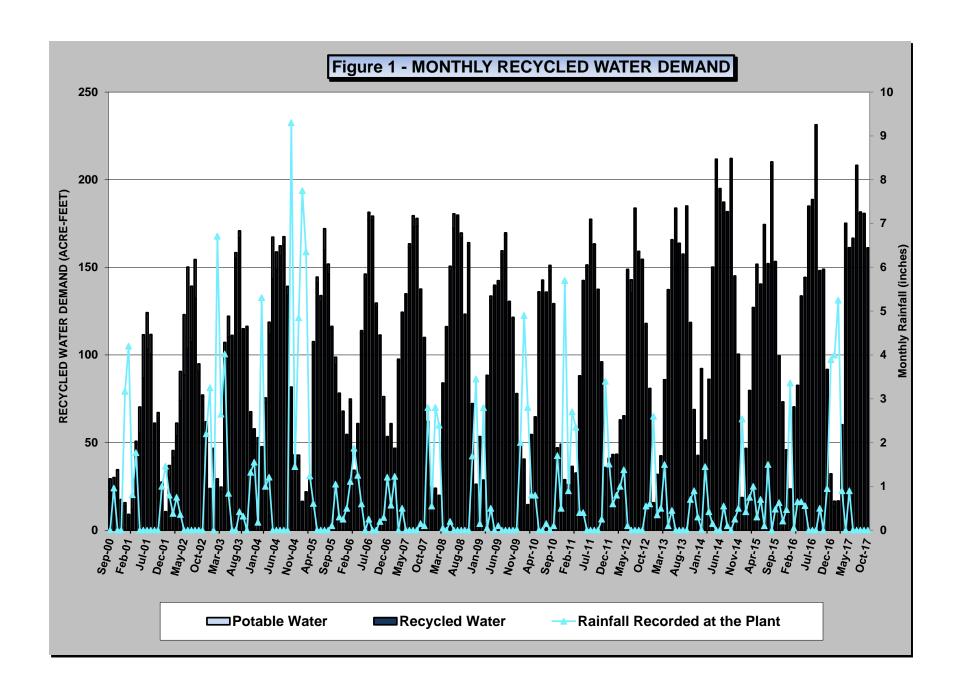

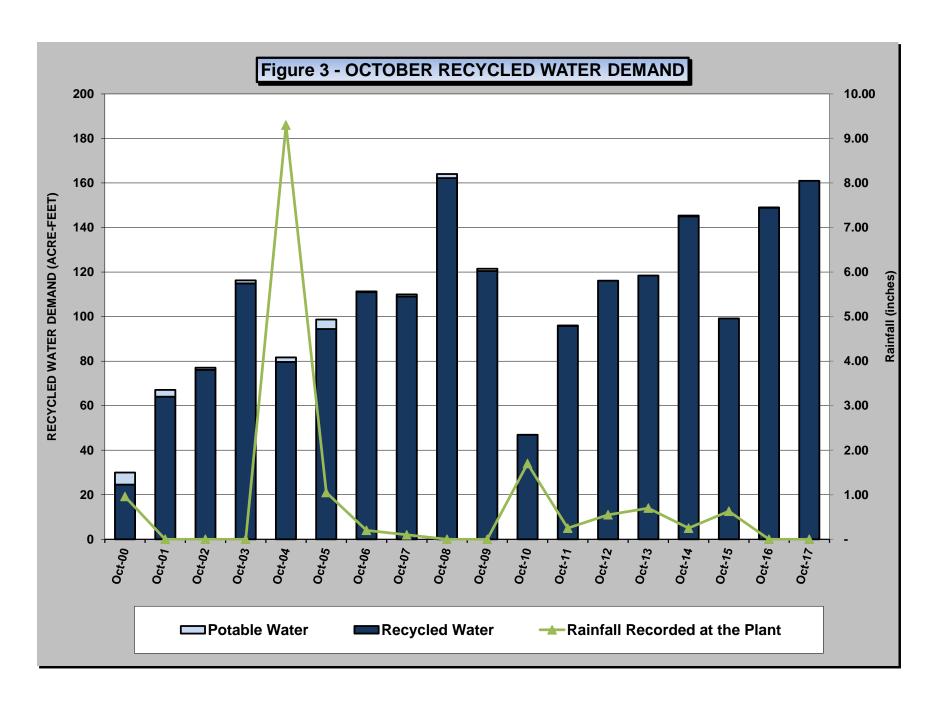

## **RECOMMENDATION**

## BACKGROUND

The San Elijo Joint Powers Authority (SEJPA) has a responsibility to maintain permit compliance with regulatory agencies and legal agreements with customers to provide wastewater and recycled water services. Proactive asset management and capital improvement planning are key components in keeping these commitments.

In 2014, SEJPA retained the services of Carollo Engineers to conduct an evaluation of the wastewater and recycled water capital assets owned by the SEJPA at the San Elijo Water Reclamation Facility.

The results of the evaluation and Carollo's recommendations were documented in the 2015 Facility Plan. Recommended projects were prioritized using a "triple-bottom line" approach to evaluate and weight each project against the others using three main factors:

- Financial (30%): Implement cost effective projects and solutions. Maximize economic benefits for customers through cost-effective operations.
- Environmental (35%): Meet or exceed permit requirements and minimize reportable violations. Improve habitat and minimize impacts to the environment.
- Social (35%): Maintain a high standard of work safety and maximize community benefits through improved aesthetics and recreational uses.

The recommendations from the 2015 Facility Plan created the foundation for the SEJPA Capital Improvement Program, which includes regulatory compliance analysis, risk assessment for system failure, project prioritization, and budgetary cost estimates.

In 2017, the SEJPA successfully secured \$23.9 million in a bond offering to fund the completion of the majority of recommended capital projects. Staff bundled the projects into four phases in

order to prioritize capital spending, streamline project delivery, minimize community impacts, and reduce cost through economies of scale.

## DISCUSSION

Phase I of the SEJPA Capital Improvement Program is currently in construction and includes the Land Outfall Replacement, Preliminary Treatment Upgrades, and Odor Control Improvements.

- The Land Outfall Replacement project will replace the existing 30-inch diameter asbestos-concrete land outfall pipeline that was installed in 1965. The new pipeline will have an installation length of approximately 2,500 linear feet, will be made of high density polyethylene (HDPE), and will be installed at a greater depth than the original pipeline to minimize conflicts with other buried utilities and future construction projects.
- The Preliminary Treatment and Odor Control projects have been combined into one
  construction contract. This project will replace or improve existing treatment equipment
  and tanks associated with the initial treatment process (referred to as Preliminary
  Treatment) at the San Elijo Water Reclamation Facility. In addition, improvements will be
  made to the odor control system that services this area of the facility.

Phase I projects have a construction budget of \$13.7 million, which are currently tracking on budget, and are scheduled to be completed in 2018.

Phase II is currently in the design and permitting stage, and consists primarily of a bundle of projects referred to as the Building and Site Improvements Program, which includes the following:

- New buildings
- Road and parking improvements
- Fire system modernization
- Storm water conveyance, attenuation, and treatment improvements
- New perimeter security fencing
- New regional bike/pedestrian path and traffic calming roundabout on Manchester Avenue in cooperation with Caltrans and the City of Encinitas.

Phase II also includes Integrated Regional Water Management (IRWM) recycled water pipelines, electrical upgrades to the Motor Control Station No. 2, and hardware and software improvements to the Supervisory Control and Data Acquisition (SCADA) system. The IRWM recycled water pipelines are in final design and the construction contract could be ready for public bidding in early 2018, with a likely construction duration of 10-12 months.

The electrical and SCADA upgrades are just entering the design phase. Detailed construction schedules have not been developed for these two projects, but consideration is being given to consolidate them into the Building and Site Improvements Program due to overlay with those projects.

Phase III, the Solids Treatment Project, is currently in the pre-design phase. A Project Definition Report (PDR) is currently in development to provide an evaluation of the design alternatives and

preferred build scenario for final design. Design is expected to be complete by third quarter of 2019, with bidding and construction beginning the last half of 2019.

Phase IV consists of Resource Recovery and Reuse projects including water storage, process optimization, and energy efficiency projects. This phase is currently in early stages of research and development.

Figure 1 below depicts the planned project groupings, anticipated budgets, and proposed phasing.

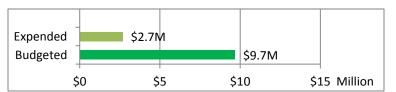

## **Project Description**

The Work includes installation of (approximate lengths) 2,500 feet of 30-inch diameter HDPE pipe via horizontal directional drilling (HDD), 400 feet of 30-inch pipe via open trench construction, 300 feet of dual 10-inch force mains via open trench construction, and 110 feet of 60-inch steel casing under Coast Highway. The HDD will begin at Cardiff State Beach, continue beneath Coast Highway (through the steel casing), the San Elijo Lagoon, NCTD railroad, the Nature Center, and Manchester Avenue before daylighting at the San Elijo Water Reclamation Facility (SEWRF). Once the HDD is complete, tie-ins will be made at the beach site and at the SEWRF. Forcemain installation will occur concurrent to HDD activities. Project work sites will be restored after final tie-ins are complete.

## Work Completed: April - November 2017

Negotiated Change Order #1 for \$158,082 credit. Coordinated with County, Lagoon Restoration and NCC I-5 project teams, performed NCTD railroad track elevation monitoring, modified City and State Parks permits for extended work hours, and conducted environmental surveys. Ongoing submittal reviews, equipment and material deliveries, and utility locating. Completed beach work pad preparation, installed HDD guidance wire system, mobilized casing and drilling equipment, and installed 60-inch diameter steel casing pipe. Fused and staged 30-inch HDPE pipe at SEWRF. Commenced dewatering and open trench construction at plant site, including Cardiff sewer forcemain valve installation.

### Planned Work: December 2017

Mobilize and complete HDD operation and HDPE pipe installation. Open trench pipeline construction for outfall and Cardiff sewer forcemain in Manchester Avenue. Work is expected to run 24 hours per day, 6 days per week (excluding Sundays and holidays) for most of December.

### **Priorities or Issues to be Resolved**

Obtain RWQCB dewatering permit. Planning and coordination for tie-ins to existing outfall system. Negotiate Change Order #2 (estimated \$94,000) for changed permit compliance requirements.

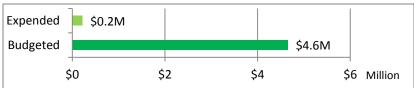

### **Project Description**

The project consists of the construction of new concrete treatment structures, installation of new screening and dewatering equipment, rehabilitation of existing concrete channels and structures, and replacement of aging chemical storage tanks. The work also includes the replacement of aging mechanical, electrical, and other components associated with treatment odor control systems necessary to capture and remove odors and corrosive gases.

## Work Completed: June - November 2017

Modified plant parking and performed asphalt striping to delineate construction areas and provide safe access. Ongoing equipment and material submittals, procurement, site mobilization, and utility conflict resolution. Installed CM trailer and temporary washer compactor to replace broken unit. Rerouted existing utilities and began demolition for new headworks channels. Approved screenings equipment submittal and released for fabrication.

Continue design of building HVAC and mechanical systems, site fire hydrant system, storm drain system, and building potable water and sewer service.

## **Priorities or Issues to be Resolved**

Develop cooperative agreement with Caltrans to define project roles and responsibilities, cost sharing terms, and deliverable dates. Prepare CEQA and MND environmental document updates.

## **Project Description**

The work consists of the design of a booster pump station and recycled water pipeline extension. The 1.5 mile small diameter (4-inch to 6-inch) pipeline will serve the community of Encinitas Ranch, two agricultural users, and the City of Encinitas trail system. The project is a key component of the SEJPA's \$2.5M Integrated Regional Water Management (IRWM) grant. The project is anticipated to offset 45 acre-feet per year of potable water use for landscape irrigation or approximately 50% of the total IRWM project potable water offset.

## Work Completed: July - November 2017

Ongoing design work to incorporate review comments and realign pipeline to comply with identified project constraints. Reviewed and provided comment for 75% design drawings.

### Planned Work: December 2017

Review 75% specifications and 100% drawings and incorporate final review comments. Meet with City staff and incorporate comments for Coastal Development Permit. Develop easement agreement for booster pump station.

Obtain Coastal Development Permit from the City and obtain easement for booster pump station from the Encinitas Ranch Golf Authority.
